Now, following the COVID-19 management protocol issued by the Government of West Bengal the person coming from Maharashtra, Madhya Pradesh, Gujarat, Tamilnadu and Delhi must be put under 14 days Institutional Quarantine from the date of entering the area.

Payment for the expenses incurred from your end will be completely reimbursed after completion of the Institutional quarantine programme and due availability of fund.
